

## RELEASE and WAIVER of LIABILITY and INDEMNITY AGREEMENT

1. THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the ASIAN SKIING & BOARDING CLUB OF L.A. (also known as ASBCLA), its directors, officers, activity leaders, and agents (hereinafter referred to as "releasees") from all liability to the undersigned, his/her personal representatives, assigns, heirs, and next of kin for any loss or damage, and any claim or demands therefor on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releasees or otherwise while the undersigned is participating in any activity affiliated with the ASIAN SKIING & BOARDING CLUB OF L.A. (ASBCLA)
2. THE UNDERSIGNED HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releasees and each of them from any loss, liability, damage or cost they may incur due to the presence of the undersigned in any activity of the ASIAN SKIING & BOARDING CLUB OF L.A. whether caused by the negligence of the releasees or otherwise.
3. THE UNDERSIGNED HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to the negligence of releasees or otherwise while participating in any activity of the ASIAN SKIING & BOARDING CLUB OF L.A..
4. THE UNDERSIGNED ACKNOWLEDGES AND UNDERSTANDS THE RISKS OF SKIING AND OTHER SOCIAL AND/OR SPORTING ACTIVITIES. Nevertheless, the undersigned hereby agrees to assume those risks and to release and hold harmless all of the persons or entities mentioned above who (through negligence, carelessness or otherwise) might be liable to me, or my heirs or assigns, for damages. It is further understood and agreed this waiver, release and assumption of risks is to be binding on my heirs and assigns.
5. THE UNDERSIGNED further expressly agrees that the foregoing RELEASE, WAIVER AND INDEMNITY AGREEMENT is intended to be as broad and inclusive as is permitted by the law of the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. This document is a legally binding contract which supersedes any other agreements or representations by or between the parties and which is intended to provide a comprehensive release of liability, but is not intended to assert any claims or defenses which are prohibited by law.
6. THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements or inducement apart from the foregoing written agreement have been made.

## About Us

The Asian Skiing & Boarding Club of LA (ASBCLA) is primarily a social and service nonprofit organization supporting skiing, snowboarding and active lifestyles. Based in the greater LA area, our members live all over Southern Calif. Membership is NOT LIMITED to Asians. The ages of members range from late 20s–60s, although it varies yearly.

With the help of dedicated volunteers, ASBCLA typically runs 3 weekend chartered bus trips to Mammoth Mountain. Drive-up trips are planned impromptu. Extended trips to an out-of-state or European ski resort are planned as interest determines.†

During the year, other activities are planned, as members step up to organize them. There have been fishing trips, whitewater rafting trips, day hikes, rock climbing, and cultural/theatrical events (Hollywood Bowl, Cirque du Soleil), etc.

Some of our community service activities include donating and decorating a Christmas tree for South Bay Keiro Nursing Home; food or toy drives benefitting service centers; volunteer staffing at the Nisei Week Festival and helping support fundraisers for various service groups, such as Be the Match.

Trips to Mammoth Mountain are usually Friday – Sunday via chartered bus, unless drive-up is specified. Prices include transportation, lodging and two continental breakfasts. On bus trips, the price also includes dinner on Saturday night. Drive-up carpools are arranged, to the extent that drivers are available.
